Division of Human Rights Studies

Human Rights Studies was founded in 2003 by a handful of lecturers from different disciplines, all specialised in human rights. We started on a small scale with a few free-standing courses and developed to a division offering a multidisciplinary bachelor programme with 130 students, a two-year master's programme and, as the only division and university in Sweden, we offer a multidisciplinary doctoral (4 years) program in the field.

Our research environment studies human rights from historical, philosophical, ethical, political, anthropological and legal perspectives. We have a particular interest in human rights in society, the role human rights play in democratic and non-democratic political systems, and what in truth it entails for institutions to respect and promote human rights.

Recently Lund University presented five research profile areas aiming to improve people's living conditions and contribute to solutions for global societal challenges. Libraries

Lund University has one of Sweden's oldest and largest research library network, with more than 30 libraries across campus. In addition, the electronic library collection includes more than 15 000 e-journals, 500 databases and many e-books, dictionaries and encyclopaedia's - a gold-mine for students and researchers. The University Library (UB) is perhaps the most exceptional. Founded in 1666 and only a few feet away from LUX.

LUX also has its own library and, together with the libraries at the Centre for Language and Literature (SOL) and the Asia library, they belong to the joint faculties of Humanities and Theology. LUX library provide subject centred support for student, researchers and teachers at the faculties. Here you can borrow books, copy, print and scan, get advice on academic writing and reference management, you'll find reading and group rooms, can get help to search for books and articles and much more.
